Bassetlaw District Council Executive Committee

is meeting in the Village Hall on Wednesday 5 June at 7.00 pm. Before the meeting, the Council will be prepared to answer questions on any subject whatsoever (although I don't think they have any more information than the rest of us about the major issue facing the country – the state of Beckham's foot!).

This is an opportunity to raise the issue of the car park in Headon. According to the results of the Village Appraisal, many of you would like to see it extended, but the District Council refuses to do this. So, our Parish Council enquired about buying it. BDC have replied that they will sell it to us for £600, plus legal fees, plus the cost of submitting a planning application if it is decided to extend the car park.

It is a public facility, its use will not change if the village owns it, except that we will then maintain it and hopefully extend it. So how can it be right for them to charge us for the privilege of taking on this responsibility which at present they are only partially fulfilling? Does anyone think it can be right for the District Council to try to avoid future costs of maintenance and still try to make a profit on the sale??

If anyone feels strongly that this is wrong, please come along to this meeting and give your support.

Parish Council News

Notes from the annual meeting held on 27 May

Election of Chairman and Vice-Chairman

The Council re-elected Eric Briggs and Janet Landon as Chairman and Vice-Chairman respectively for the coming year.

Code of Conduct

Following the Nolan Committee Report on Standards in Public Life, all Parish Councils are now required to adopt a Code of Conduct and members are required to sign an agreement to abide by it. The Council has now complied with all the requirements of the Code.

Car Park

This matter will be raised at the meeting of the District Council's Executive Committee to be held in Headon-cum-Upton Village Hall on 5 June. If anyone feels strongly that it is wrong for the District Council to charge the Parish Council £600 plus legal fees (plus the cost of submitting a planning application if it is decided to extend the car park) please come along and add your support.

Grass cutting

The fact that the County Council is still cutting the grass, as well as North Notts Landscapes, is a result of a misunderstanding which will be rectified.

Councillors felt that, after some teething problems, the first cut by North Notts Landscapes had been satisfactory. The Council would appreciate some feedback from village residents before deciding whether to continue with grass cutting in 2003.

Grants for Churchyard Maintenance

The Council agreed to make grants of £200 to each of the three Churches. In view of the fact that the grant increased from £140 in 2000/01 to £160 last year and now £200, the PCC will be asked to ensure that the small area of grass between the churchyard and the road is cut regularly.

Best Kept Village Competition

The village has again entered the Best Kept Village Competition. Although it is difficult for working villages such as ours to win, the village certainly looked neater as a result of last year's entry in the competition.

Cycle Route Signs

Last month the County Council had advised the Parish Council that it was their policy not to permit the erection of unnecessary signs on highways. This month a proliferation of signs advertising a cycle network has appeared! A case of one rule for the villages and another for the County Council.

Property marking kit

The second property kit, which was supposed to be kept in East Drayton, can't be found. The Council decided that a register should be kept of people borrowing the other kit from Headon-cum-Upton Village Hall.

Planning Application

Extension to Sewage Treatment Works

The Council welcomed the proposal to expand the plant provided that the applicant is required to carry out a survey regarding the existence of a badger sett. The Council would like to see a condition attached to the planning permission requiring some screening of the plant from Yew Tree Road.

Dog Fouling

It has been brought to the Council's attention that dog fouling is an increasing problem, particularly in Nether Headon and near the village sign. Apart from being unsightly, this is a hazard to health, particularly to those, contractors or volunteers, who maintain the grass verges. The Council would like to ask dog owners to clean up after their pets. However, if the problem persists the Council will have no alternative but to ask that all grass verges in the village are designated areas under the Dog Fouling Act 1996. This legislation makes failure to clean up after dogs a criminal offence with a fine of up to £1,000.

The next meeting will be held on Tuesday 2 July at Grove Church Hall at 7.30 pm. Members of the public are cordially invited to attend.

We do consider, however, that a condition of approval ought to be that they should screen the plant from the road with trees or shrubs and will make this comment to the Council.
