## **Parish Council Elections**

The Parish Council is due for election this year. If you want to stand for election, you will need a nomination form (available from the District Council's office in Worksop), and a proposer and seconder both of whose names must be on the electoral roll for Headon-cum-Upton. Nomination forms can be submitted anytime between 17 March and noon on Tuesday 1 April. If the election is contested the poll will take place from 8.00 am to 9.00 pm on Thursday 1 May at the same time as the poll for the election of a councillor to represent Rampton Ward on Bassetlaw District Council. There will be no cost to the village of holding an election.

## **Parish Council News**

### **Notes from the meeting held on 3 March**

*(It should be stressed that these notes are based on my recollection of what was agreed at the meeting and not on the approved minutes)*

#### **District Council Contribution to Parish Councils**

At its previous meeting the Council considered the implications of possible cuts of 50% or 20% in the money it receives from Bassetlaw District Council. At the same time it was widely reported that the District Council was intending to eliminate its Arts and Tourism budgets. Following widespread complaints it appears, although there has been no official confirmation of this, that the Arts and Tourism budgets have been reinstated and that the reduction in the District Council's contribution to Parish Councils will only be 20%.

#### **Grass Verges**

Members were unanimous that the grass verges have never been in a worse condition. There are many reasons for this – people have blamed agricultural vehicles, buses etc – but, essentially, they boil down to the fact that vehicles are travelling too fast. Parish Councils have certain powers in relation to roadside verges without consulting the County Council and the Council decided to discuss the matter further at its next meeting.

#### **Freedom of Information Act**

Parish Councils are required to adopt a scheme under the above Act. The Council has done this and had the scheme approved by the Information Commissioner and the scheme will run from 28<sup>th</sup> February 2003 until 28<sup>th</sup> February 2007. What this means in summary is that members of the public are entitled to ask for printed copies of certain Council documents (eg the minutes of meetings) relating to the last two years. This does not affect electors' existing rights to, for example, inspect the minutes of Council meetings (since the year dot) or question the auditor in accordance with the timetable which is published at the time of each annual audit. More details of what information is covered by the scheme will be published later.

#### **Bassetlaw Local Plan**

The Local Plan is the District Council's definitive statement of policy. It defines areas which are considered suitable for development and those which aren't. Specifically it sets out village envelopes, within which there is a presumption that planning permission for new buildings will be granted, provided they are deemed to be 'in character with existing buildings', and outside which development will not normally be allowed. (Upton has a village envelope, Headon doesn't).

The plan is in the process of being revised. The Parish Council, and interested residents, have the opportunity to comment on the proposals. (The consultation period on this plan is lengthy – at least two years).

As the first reference point for all planning applications is whether they comply with the Local Plan, I thought it would be helpful to set out the procedures relating to planning applications. The law defining when planning permission is required is complex but includes:

- Any new building;
- Any extension of an existing building which fronts onto the highway;
- Any extension to, or replacement of existing buildings, not fronting the highway which in terms of its size or its effect on the local environment is 'significant';
- In Conservation Areas only, the demolition of buildings and the felling of trees;

The District Council is required to advertise that a planning application has been made, always by posting a notice as near as possible to the proposed development and usually by notifying neighbours directly. The Parish Council is always consulted on planning applications.

Any member of the public has the right to comment on planning applications. The District Council is required to consider all objections to a planning application; common sense would indicate that they give more credence to an objection from someone with personal knowledge of the property.
